### Board Meeting Minutes

May 26th, 2022 @ 6:00 PM

**Opening Prayer:** Chairman Barbie Blansett

**Meeting called to order:** Meeting called to order by Chairman Barbie Blansett.

**I. Reading of the April 21<sup>st</sup>, 2022, minutes. (Approval/Disapproval):** Missi Cox made the motion to approve the April 21<sup>st</sup>, 2022, minutes; Fred Newcom 2<sup>nd</sup> the motion; motion carried.

**II. Standard Business:**

#### **Principals Report: Sandra Crabtree**

- We had all our fundraising rewards for the students—pizza parties, Kona Ice, PJ/Hat Days, candy scramble and marshmallow wars.

- Prom was held on Saturday, May 7<sup>th</sup>.
- Life maze was attended by grades 7-12 on May 9<sup>th</sup>.
- K-1 field trip to Chattanooga Zoo.
- Field Day—organized by the Field Day Committee went well.
- Student Talent show was held on May 11.

- Awards days/nights—Senior Banquet/Awards Night—May 12<sup>th</sup> 8<sup>th</sup> grade graduation/awards night—May 17<sup>th</sup>; Grades K-5, awards, May 20<sup>th</sup> and grades 6-11<sup>th</sup>.
- Grades 2-5 and 6-8 attended the Whitwell Middle School Chorus production of The Little Mermaid.
- Seniors had events during Senior Week—water games, senior picnic, escape room, senior lunch, senior sunset at Top of the Rock.

### **Financial Report: Jennifer Olton**

Jennifer reported that both bonds have been paid and all expenses are current and up to date. The floors are complete that was paid for by ESSER 3.0 fund and look great. We are still waiting on TNRMT invoice so that the SY23 budget can be finalized. We are also getting 2 new servers that will be purchased in June, the cost is approximately 20K for both.

### **III: Old Business:**

**Bids on Historical Building:** Neither bid has been updated or returned as of the board meeting. Both should be back in for the next meeting.

**Special School Tax:** We finally have an answer for the Special School Tax. According to Mr. Cagle who spoke with one of our congressmen the Special School Tax is being put on hold. The reason being that with the onset of the new BEP changing to TISA as of SY24 and for the first 2 years our local tax will be

lower and will gradually increase into the new formula which will be more money for the schools.

#### **IV: New Business:**

Director Interview with candidate Sharon Allison. Chairman Barbie Blansett called Sharon Allison to the table so she could formally be interviewed by the board for the Director's position. (Board member Fred Newcom did not participate in the interview). Chairman Blansett began the interview and asked Ms. Allison as a Director would you ever re-hire terminated employees. Ms. Allison responded by saying "no, that would be going backwards, and we want to move forward". Chairman Blansett next asked, would you bring back employees that had quit; Ms. Allison responded by stating "it depends on the situation and why they may have left, we have let other employees return in the past". The next question that Chairman Blansett asked Ms. Allison, could she work with our current Principal Sandra Crabtree; Ms. Allison responded by stating "she could definitely work with the principal and did not have any issues". The last thing that was asked, was about Ms. Allison's experience and years at RHMS. Ms. Allison stated that she has been at RHMS for 17 years and for 8 of those years she has served as the Federal Programs Director. Chairman Blansett then proceeded to ask board member Missi Cox if she would make the motion to approve Sharon Allison as the new Director effective July 1, 2022. Missi Cox made the motion to approve Sharon Allison as the new director; Chairman Barbie Blansett 2<sup>nd</sup> the motion; motion carried. (Fred Newcom did not participate in the voting).

**Out of State Teaching Experience:** Jennifer Olton stated to the board that in the past when a teacher came from another state their years of experience was started over at 0 and they lost their previous years of experience. This was approved around 10 years ago to help off-set some of the financial issues that were occurring. It has since come to our attention that other states like Alabama is giving their teachers a significant raise and to retain the teachers, we have from other states their years of experience should be reinstated which would raise their current pay. Jennifer looked at the 5 teachers that we have from other states and if we did reinstate them, we would only be looking at about a \$29,000 increase. This not only helps with those teachers that are here at RHMS but any future teachers that we get from other states will be able to keep their years of experience and make more money. Chairman Barbie Blansett made the motion

to re-in state teachers' years of experience from other states; Missi Cox 2<sup>nd</sup> the motion; motion carried.

**Trainings/Workshops/Field trips/Fundraisers:**

Laci Boston (FRC) will be attending an FRC training on June 9<sup>th</sup> at Murfreesboro. Chairman Barbie Blansett made the motion to approve the training; Fred Newcom 2<sup>nd</sup> the motion; motion carried.
