Adding Susan Layne as a check signer: Teresa Lakey presented to the board that Susan Layne should be added as a check signer for Richard Hardy, she also stated that it must be noted that Sharon Allison Newcom will be staying on as a check signer but will also be changing her last name. All the information required for the changes along with the minutes will be taken to the bank. Fred Newcom made the motion to add Susan Layne as a check signer; Chairman Missi Moore 2<sup>nd</sup> the motion; motion carried. Chairman Missi Cox made the motion to keep Sharon Allison Newcom as a check signer; Rhkisha Whisnant 2<sup>nd</sup> the motion; motion carried.

**Athletic Director Stipend:** The board discussed that if we do not have but one sport that is taking place, then the stipend for the Athletic Director should be based on a percentage and not the full amount. Principal Reggie Culpepper stated that he would discuss this with the AD and explain that with the lack of sports the full stipend cannot be supported. Fred Newcome made the motion to approve that the AD stipend be based on how many sports we have for the school year; Rhkisha Whisnant 2<sup>nd</sup> the motion; motion carried.
